CITY COUNCIL MEETING MINUTES

WEDNESDAY OCTOBER 2, 2024

7:30 PM

COUNCIL SELECTION OF COUNCIL PRESIDENT – ACTION ITEM:

President of the council conducts meeting in the event the mayor cannot attend a meeting. Does not have any executive authority.

Mayor recommends Jen Campbell. Morgan nominates Jen as well, Vaughan seconds. Voting is in favor.

KARA TIM/CAPSA – DOMESTIC VIOLENCE AWARENESS:

Brought a pledge board to have the council sign. By signing we can spread the word about domestic violence and let people know help and resources are available through CAPSA.

BRAYDEN & SHANTAE GAMBLES 208 HOT SHOT BUSINESS LICENSE APPROVAL – ACTION ITEM:

Brayden and Shantae are starting a truck delivery business. Morgan makes a motion to approve 208 Hot Shot business license, Vaughan seconds; voting is in favor.

The Council wants it to be known that they cannot park any truck and trailer on city easements.

JC EGBERT AG BUILDING PERMIT – ACTION ITEM:

Has an ag shed that he would like to build. Peak is 24 ft., sidewalls are 18 ft. Morgan makes a motion to approve JC Egbert’s building permit, Vaughan seconds; voting is in favor.

WESTON CREEK IRRIGATION WATER LINE DISCUSSION:

Weston Creek is planning on moving the water line to the north side of the grandstands, so Steve wants the city to wait to put in a line to use our irrigation shares until Weston Creek has done that because it will save the city a lot of money.

Steve needs to be ready to put in that line when they come to move their water line.

2024 FY END OF YEAR REVIEW:

Denise passed around the final budget items for 2024. Overall, the city was under budget. Denise will post those numbers in the window at city hall.

APPROVE SEPTEMBER MINUTES – ACTION ITEM:

Jen makes a motion to approve September minutes, Vaughan seconds; voting is in favor.

APPROVE SEPTEMBER BILLS – ACTION ITEM:

Morgan makes a motion to approve September bills, Vaughan seconds; voting is in favor.

DELINQUENCY LIST:

Denise sent 1 delinquent water bill to the county to be added to the resident's property taxes. All other delinquencies have been paid.

MAYOR'S REPORT:

Mayor's walking challenge started yesterday, he will be walking 10,000 steps a day to get the city another \$1000.

PUBLIC COMMENT:

Mike Wilson & Micah Talbot are write-ins for the Franklin County Sheriff. They have 40 yrs combined in experience and have a lot of experience within communities.

Things they want to incorporate if they are voted in are:

- Rent a cop, bring in more deputies to serve the communities.
- Youth Corp program
- Citizens on patrol program
- Kelly Biggs will be brought on for administrative duties and training plus others that can help with dispatch.
- Franklin county is behind the times, they don't have the tools they need to do their job. Turnover has been very high within the last 12 years; he wants to change that so people feel comfortable while doing their job. He will be a working sheriff, will be dedicated to work for the communities and having a presence. Franklin county doesn't have 24-hour coverage and he wants to change that.
- Train deputies as EMT's since the police officers are usually first on the scene of accidents. These things will not raise taxes.

The mayor asked about him putting in a jail. Mike said that Franklin County needs to have a plan for the next 5-20 years. Even though a jail won't be put in right away, the county still needs to be plan for and have a goal in mind to get one in

Franklin County. He also wants to send felons to Caribou County Jail so they don't have to do through the process to extradite prisoners at Cache County Jail to courts in Idaho.

Both Mike and Micah have CIT (Crisis Intervention Training) experience, but Franklin County does not have that available for the community or officers. Micah has 20 years of experience. He's worked 3 years for the Franklin County and has been frustrated. Instead of changing he wants to adjust by prepping for the worst. He will push to get 24-hour coverage, because things are happening between 2 am - 4 am but no one is on duty from 2 am – 6 am. Outside cities are all neglected, ignorance & leadership needs to adjust to get presence within the communities.

Neither one made it in the primary, so Mike is running as an independent and able to write in with Micah Talbot as running mate. Their combined votes were 55% in the primary versus Stoker's 46%.

Jen wants to sign up for ICRMP training and hopes to get it recorded so the other council members can watch it.

She wants to get thank you cards to donors from the celebration.

She wants each council member to be on agenda from now on to report over their assigned committees.
